CITY COUNCIL ACTION ROUNDUP: June 25 and June 26, 2024 City Council Meetings

June 25 City Council Meeting

- Authorized the City Manager to amend the contract with Prentice Long for a time extension until December 31, 2024, to complete comprehensively updating the City of Willows Municipal Code.

Willows High School Interns Learn about Municipal Government

Using the \$5,000 grant the City received from the Judy L. Kelsey Memorial Fund Awards Program, the City created two paid summer internships offering two Willows High

School students the opportunity to work in and learn about City Government. A total of 10 highly competitive applications were received. The following two Willows students were selected and have spent the past six weeks learning about the various aspects of municipal government, including Community Development, urban planning, code enforcement and customer service at the front counter and over the phones.



Helen Harlan Helen is a 17-year-old senior at Willows High School. She is involved in various clubs and sports, including FFA, Fellowship of Christian Athletes, ASB leadership, volleyball, and track. Sycamore Park and Pool Upgrades

In the second half of 2023, the City of Willows was awarded a Clean California grant of slightly more than \$4 million to upgrade and improve Sycamore Park and the City's Swimming Pool.

On July 18, 2024, the City of Willows received two bid proposals for design services of the Willows Mobility, Recreation, and Beautification Project. Once staff reviews the proposals and the lowest responsible bidder is identified, the bidder will be presented to Council for approval and a contract will be executed. As a reminder, project improvements to restore and upgrade the community pool complex and Sycamore Park include:


- Pool Rehabilitation: Remove fiberglass coating in both the main and tot pool, and replaster both; install lane lines in the main pool; replace depth markers; replace concrete decking around the pools; renovate mechanical equipment; replace disinfection system; replace filter media; replace fencing around the pool; replace starting blocks; install a new shade structure on the existing concrete pad (located adjacent to the main pool area); install a portable/mobile lifeguard stand; install an Americans with Disabilities Act (ADA) compliant pool lift; replace electrical panels; and consider replacement of the diving board stand.
- Adding new curb ramps and over 2,000 linear feet of sidewalk along the perimeter of the park.
- Reconstructing over 2,100 linear feet of pathways inside the park with new mixed use concrete pathways.
- Installing new trash receptacles and drinking fountains in the park.
- Installing new solar facilities needed to illuminate park interior pathways, the tennis court area, and to provide power to the pool heater. The solar facilities will be installed on both the existing pool changing room/bathroom building, as well as on top of a shade structure proposed at the pool area.
- Resurfacing of the existing tennis courts and two of the existing four courts will be repurposed into six (6) pickleball courts.

Annual Paving Project

The Annual Pavement Project is complete! Streets were treated with a rubberized cape seal which is designed to extend the life of pavements in fair to good condition. Cape seals provide the benefits of both the chip seal and the micro surfacing treatment, namely sealing moderate cracks, providing skid resistance, sealing the pavement against moisture intrusion, protecting the structure from further oxidation and raveling, and restoring a uniform black appearance. The following locations were treated:

- Cape Seal North Humboldt Street between Wood and Sycamore Streets;
- Cape Seal Sycamore Street between North Humboldt Street and Villa Avenue;
- Cape Seal Crawford Avenue between Sycamore and Laurel Streets;
- Alley Aprons Alleyway between South Shasta and South Butte Streets; and

• Curb Ramps, Curb/Gutter and Sidewalks - Various locations on North Humboldt Avenue, Sycamore Street, and Crawford Avenue.

Master Fee Schedule

There is no record of the last time the City's fee schedule was comprehensively updated. For example, some fees have not been updated since the 1990's. Because the City's Master Fee Schedule is long overdue for review and adjustment, staff circulated a Request for Proposals to hire a qualified consultant to review and recommend changes to the Schedule. Since then, the schedule has been updated and the City Council adopted the new Master Fee Schedule at the June 25, 2024 City Council meeting. All fees are updated based on the estimated time it takes for staff and contractors to issue, inspect and finalize permits. The new fee schedule will be implemented by September 1, 2024.

Code Enforcement

Code Enforcement Efforts

The City will increase efforts to enforce the Willows Municipal Code (WMC) Title 8-Health and Safety. In particular, enforcement will focus on three main areas:

- 1. Accumulation of rubbish on properties,
- 2. Food handlers operating without appropriate licenses, and
- 3. Unsafe residential buildings.

We want Willows to be a safe, attractive place for residents and businesses, enforcing code violations is one way to assist in reaching this goal. As part of these efforts, we will increase drive-around inspections and issuing violations to those not in compliance



FIRE

Fire Response, Prevention & Emergency Medical Services

Major Incidents

Vehicle Fire

On June 13, 2024, the Willows Fire Department (WFD) was

dispatched to a reported car fire near the Highway 162 overpass. Firefighters arrived on scene to find a fully engulfed van with all occupants safely out of the vehicle. Fire Personnel were able to quickly extinguish the flames and neither of the occupants were injured. The cause of the fire is still under investigation; however, it is believed that there may have been a problem with the fuel line.



Vegetation Fire

On June 23, 2024, WFD responded to a vegetation fire in the area of CR 68 and I-5. Units arrived to find a ¼ acre vegetation fire moving with a moderate rate of spread threatening a structure. Units began an offensive fire attack and mitigated the threat, extinguishing the fire before damage to structures could occur. No injuries occurred on this incident. The cause of the fire was determined to be from mowing.

Vegetation Fire

On June 23, 2024, WFD was dispatched to a vegetation fire in the area of CR 49 $\frac{1}{2}$ and CR KK. Units arrived to find a fast moving vegetation fire threatening several residential homes. Units extinguished the fire before any injuries or damage to homes occurred. The cause of the fire was determined to be substandard wiring.

Public Events

On June 7, City Firefighters were out at Walden Academy and Murdock Elementary helping everyone stay cool with a Water Day. The WFD set up the engines and sprayed a nice cooling mist for everyone to play in and celebrate the end of the school year.



Community Information - Red Flag Warning

In June, Glenn County experienced record-setting temperatures that have remained consistent through July. On June 15, the north state received its first RED FLAG warning of the 2024 fire season. There have since been several more issued. Please be cautious

and avoid activities such as mowing or other hot work on red flag warning days. For more information, please review the flyer below.



Wildland fire is an increasing threat and a year-round reality in many areas. As a resident, it's important to educate yourself and do your part to prepare.

The Ready, Set, Go! Program provides valuable guidance to increase the safety of you and your family. This includes speaking with local fire department personnel about your area's threat for wildland fire and learning more about the wildland urban interface (WUI), an area which is not only limited to forest vegetation.

Create defensible space by clearing brush away from structures. Use fire-resistant landscaping and harden structures using fire-safe construction. Assemble emergency supplies and belongings in a safe place. Plan escape routes. Prepare and share your action plan with everyone involved.



Put together a "Go" kit. Learn how to receive and stay aware of the latest news and information on the fire from local media, fire departments and public safety agencies.



Follow your personal wildland fire action plan. Doing so will not only support your safety, but will allow firefighters to best maneuver resources during a fire.





What is a Red Flag Warning?

A Red Flag Warning is a **weather warning** issued only by the National Weather Service for a select area.

This warning forecasts warm temperatures, low humidity in dried fuel moistures, and strong winds expected within 24 hours. The combination of these increased risks results in an increased risk for a wildland fire or rapid-fire growth if an incident were to occur.


During a Red Flag Warning, **ALWAYS** follow the instructions provided by your local fire department and maintain a heightened awareness of anything that can generate a spark or flame. **ALWAYS** be prepared to take action if a wildland fire develops in your area.






A fire adapted community is a community located in a WUI that requires little assistance from firefighters during a wildland fire. Residents accept the responsibility for living in a high fire-hazard area. They possess the knowledge and skills to prepare their homes and property to survive wildland fire and evacuate early, safely, and efficiently.
