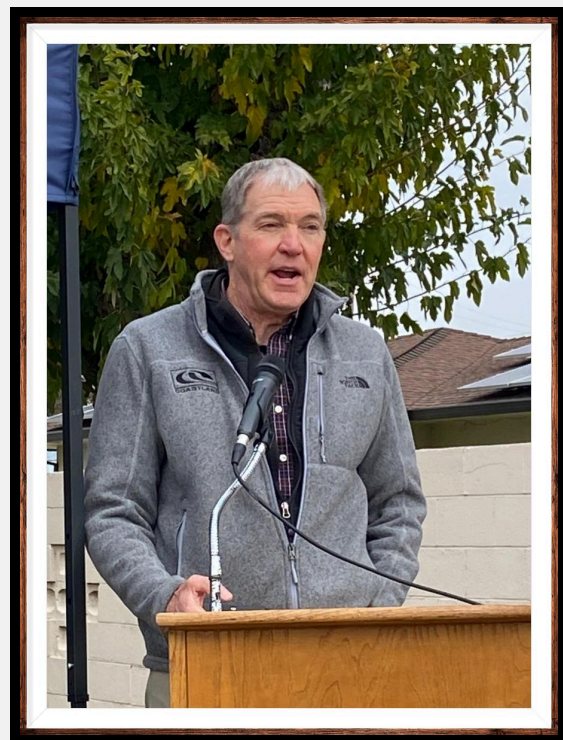

City Council Action Roundup:

November 25 and December 9 City Council Meetings

November 25, 2025 Council Meeting

- Approved Resolution 37-2025 accepting the improvements for the Willows Lift Station Rehabilitation Project and authorizing the Notice of Completion to be filed for the project.
- Approved Resolution 38-2025 accepting the improvements for the Emergency Library Roof Failure Project and authorizing the Notice of Completion to be filed for the project.
- Authorize the City Manager, or her designee, to execute a contract with Healthcare Strategist Solutions, in partnership with Glenn County and the City of Orland, for the purpose of performing an Emergency Medical Services System Assessment in an amount not to exceed \$48,000.
- Elected Mayor Hutson and Councilmember Pride to a subcommittee to review applications, conduct interviews, and return to the full Council with a recommendation for appointment to the Library Board of Trustees to fill the remaining term, vacated by Lisa Kennedy, that is scheduled to expire on June 30, 2028.
- Approved the renewal of the City's Street Banner Program contract with CGI, and directed staff to include the designers who previously worked on the Wayfinding Sign Project.
- Adopted Resolution 39-2025 establishing the 2026 Council Meeting Calendar and Schedule.

December 9, 2025 City Council Meeting

- Approved the updated job classification for the full-time Children's Librarian position, as well as the new salary schedule for the position.
- Adopted Resolution 40-2025 approving the implementation of Paramedic and Advanced Emergency Medical Technician (EMT) incentive pay for Fire Captains and approving the updated and revised Fire Captain Job Classification.

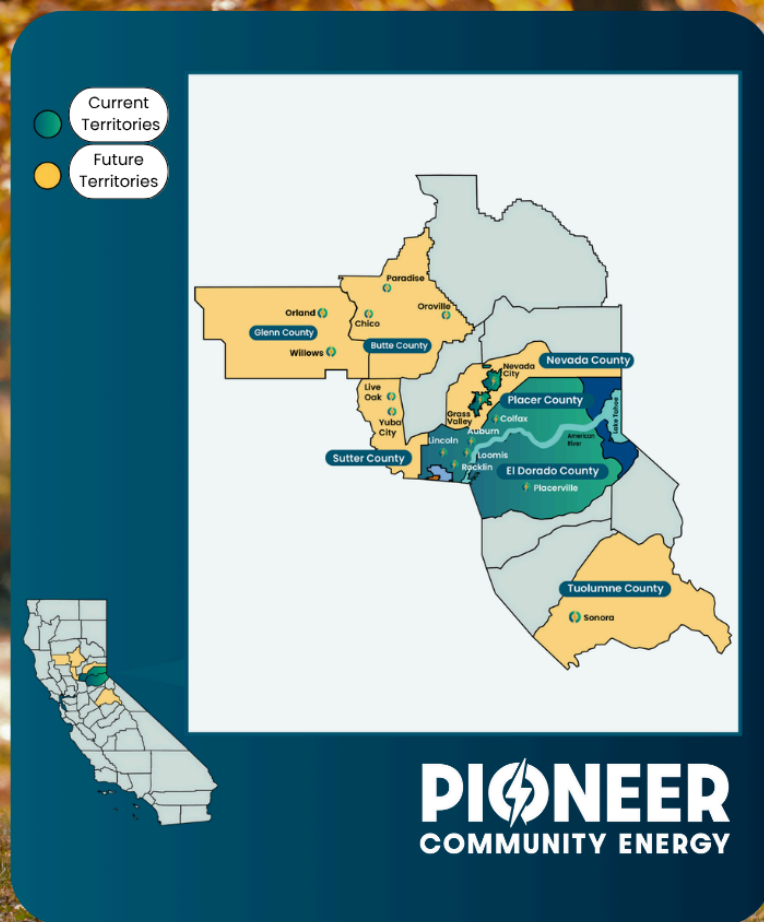
Pioneer Community Energy launches in 2027

In October 2027, Pioneer Community Energy, a local, not-for-profit electricity provider in Northern California that acts as a [Community Choice Aggregator \(CCA\)](#), will launch in the City of Willows. Pioneer will become the City's default provider for the electricity generation portion of residents' bills, while PG&E will continue to deliver power and maintain the poles and lines (e.g., transmission, distribution).

Beginning in the fall of 2026, Pioneer and the City will launch a public education campaign to share FAQs, host community outreach activities (e.g., town hall and community group meetings), and provide information about the new program so that residents and businesses may understand their electricity provider choices ahead of the October 2027 service launch. Should customers prefer, there is also the option to opt out of the program and remain with PG&E as their electricity provider.

Pioneer reports it has saved customers more than \$108 million between 2018 and 2024, with savings reinvested into communities through local power purchase agreements, economic development projects, and other community investments. Code Enforcement Division

Humboldt Avenue Apartment Complex

The City's Code Enforcement Officer recently conducted an inspection of a Humboldt Avenue apartment complex and observed areas of structural deterioration, safety concerns, and unresolved building permit issues. The Code Enforcement Officer has been in contact with the property management team and, in coordination with the Fire Chief, will conduct a more comprehensive inspection of the complex to further assess conditions and determine appropriate corrective actions. The property management company's contractor, who was on

site during the initial visit, will also participate in these follow-up inspections to cooperatively address identified code violations.

Sycamore Park Improvement Project – Bid Solicitation Underway

The City of Willows is pleased to announce that the Sycamore Park Improvement Project is officially out to bid for construction. This project is predominantly funded by a \$4,038,000 Clean California Local Program Grant awarded by the State Department of Transportation, as well as a \$200,000 contribution from the County of Glenn and \$177,952 in Proposition 68 grant funds dedicated to improvements of the community pool complex.

The project includes construction of new curb ramps and more than 2,000 linear feet of sidewalks around the perimeter of Sycamore Park, as well as replacement of approximately 2,100 linear feet of walking pathways within the park. Additional park enhancements include resurfacing the tennis court area and converting two of the existing courts into six new pickleball court with stadium lighting, along with the installation of new trash receptacles and picnic tables throughout the park.

Significant upgrades are also planned for the City Swimming Pool complex. These improvements include reconstruction of the concrete decking around the main pool, replastering, renovation of mechanical systems, replacement of disinfection and filter media systems, electrical upgrades, installation of a portable lifeguard stand and ADA pool lift, construction of a new roof on the pool house, ADA compliant pool house renovations, and new perimeter fencing.

Bids for the Sycamore Park Improvement Project are due by January 8, 2026. The project is expected to be completed within six months of contract award with the City swimming pool rehabilitation prioritized first. Unfortunately, however, it is unlikely that the swimming pool will be renovated in time for the City's 2026 Summer Swim Program. As a result, the City

The City of Willows is now accepting applications for two upcoming vacancies on the Planning Commission. The open seats are currently held by Commissioners Cristina Ocampo

and Sherry Brott, whose terms will expire on December 31, 2025. The new appointees will serve full four-year terms from January 2026 through December 31, 2029.

Residents interested in serving the community are encouraged to apply. Applications are available in person at City Hall and on the City [website](#). Applications are due to the City Clerk's Office no later than December 29, 2025, at 5:00 p.m. All submitted applications will be reviewed and applicant interviews will be conducted by a Subcommittee of the City Council. Appointments are anticipated to be made at the next Regular City Council on January 13, 2026.

December 2 Planning Commission Meeting

- **Road 57 Chevron - (APPROVED)**

Chevron fueling station owner at 1481 South Tehama Street in Willows proposed to expand and upgrade the property into a full-service commercial fueling and service center. As part of the project, the existing convenience store would be enlarged to ~ 7,607 square feet and would incorporate showers, a lounge area, and a fast-food restaurant with a drive-through window. The site would be reconfigured to provide ten diesel fueling lanes, six electric truck charging stations, and eight electric vehicle charging stations, along with two additional multi-product fueling pumps and a new canopy dedicated to recreational vehicles. The plan also identifies future areas for hydrogen and compressed natural gas fueling, including the necessary storage facilities. In addition, a new truck service center is proposed, which would include office space, a customer waiting area, two service pits, and a truck wash. The project further includes installation of a truck scale and a range of site improvements, such as upgraded drainage infrastructure, stormwater management features, and drought-tolerant landscaping.

- **Wayfinding Sign Review - (CONTINUED)**

The Planning Commission reviewed both the original and revised “Welcome to Willows” wayfinding sign mockups prepared by SignCo, along with the classic antique poles. The Commission directed that certain elements from the revised mockup be incorporated into the original design. Funding was also available for new classic antique poles. This item will return to the Planning Commission in January for final review and approval.

Public Works Division

Fallen Tree on Walnut Street

On November 26, Public Works on-call staff responded to a report of a large broken tree limb on Walnut Street between North Plumas and North Shasta Streets. A major limb had split from a street tree and fallen into the roadway, blocking part of the travel lane and creating a

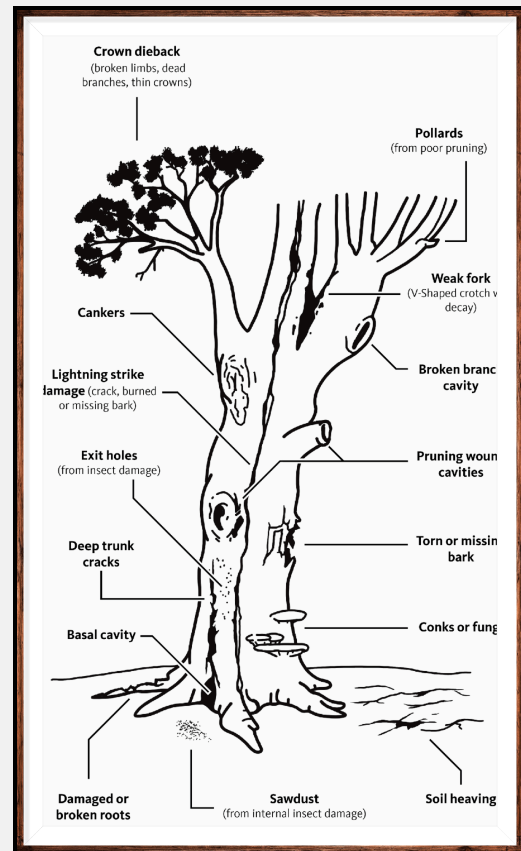
safety hazard for drivers and pedestrians. Crews quickly responded, cleared the debris, and secured the area.



Preventing Hazardous Tree Failure

Healthy, well-maintained trees are safer and more resilient during storms. Here are some ways the community may help reduce the risk of falling limbs and trees:

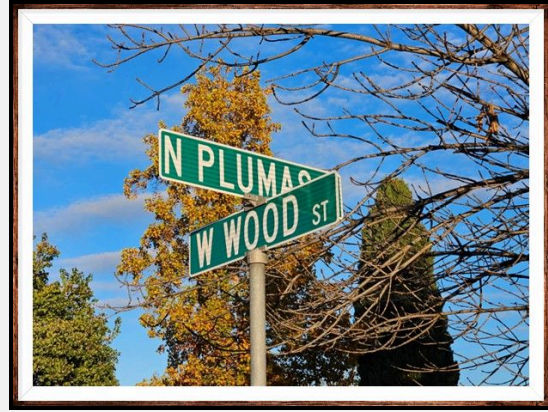
- Inspect trees regularly.
- Look for dead branches, cracks in the trunk, large cavities, fungi at the base, or branches that hang over sidewalks, streets, or structures.
- Use qualified professionals to determine tree health.
- Hire a licensed, certified arborist for major pruning or tree removal, especially for large trees or anything near buildings, streets, or power lines.
- Keep branches clear of streets and sidewalks.
- Trim low branches that block visibility, street signs, or pedestrian access, following safe pruning practices.
- Stay away from power lines!
- Never prune trees that are close to overhead electrical lines. Contact the utility provider if you see branches growing into or around power lines.
- Report problem trees early.
- If you notice a tree in a City Park or property, that appears damaged, leaning, or dropping large limbs, contact the Public Works Department so it can be inspected.



New Street Name Signs Arrived!

The City of Willows is pleased to announce that new street name signs have now been installed along Wood and Tehama Streets, and Public Works crews are continuing installation throughout the community. All signs for the citywide replacement have been received, and the remainder of the signs will be installed in sections in the upcoming months. The upgraded signs feature clearer lettering, improved reflectivity, and a consistent design to enhance

visibility and safety for drivers, pedestrians, and emergency responders. This citywide effort will ensure all neighborhoods benefit from improved wayfinding and a cleaner, more cohesive look.



Welcome Travis Harris, New City Mechanic!

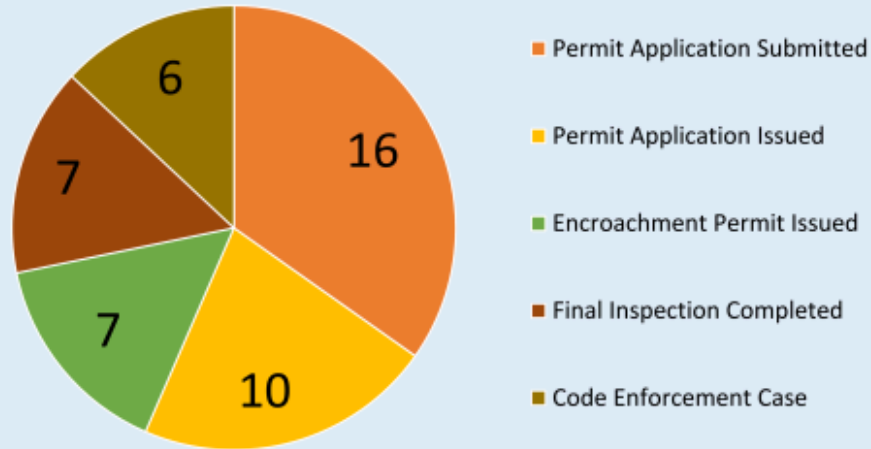
The City's new mechanic, Travis Harris, has been hard at work catching up on deferred vehicle and equipment maintenance since joining the team. He services both Public Works and Fire Department vehicles, helping keep the city's essential equipment safe and reliable. Travis prepares and submits required reports and documentation to keep the City in compliance with the Air Resource Board, Bureau of Automotive Repair, and various other agencies.

Since joining the team, Travis has jumped right into several major projects, including replacement of the radiator in the leaf truck (shown at right) and installment of a new water pump on the sewer jet truck—crucial repairs that help prevent downtime and extend the life of critical equipment. Travis has also been evaluating overall fleet requirements, prioritizing repairs, and helping strengthen preventive maintenance efforts so that City vehicles may remain in service longer and operate more efficiently.

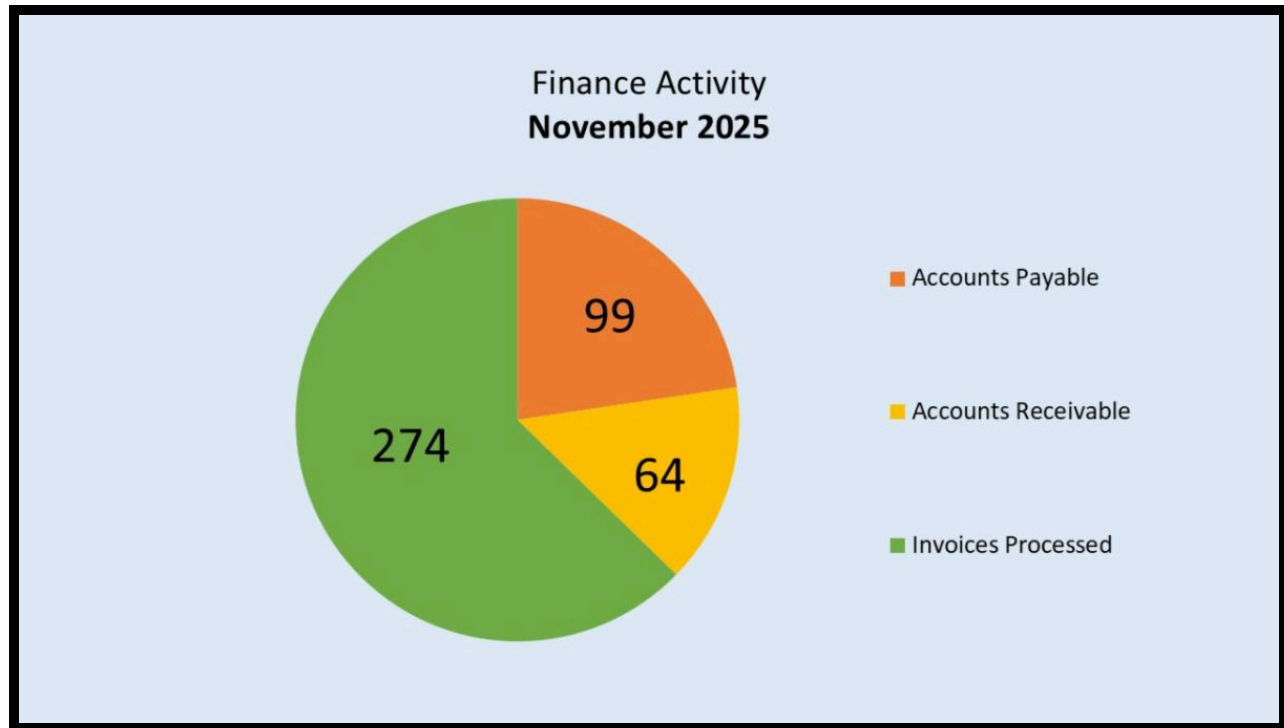
New Finance Director Appointed!

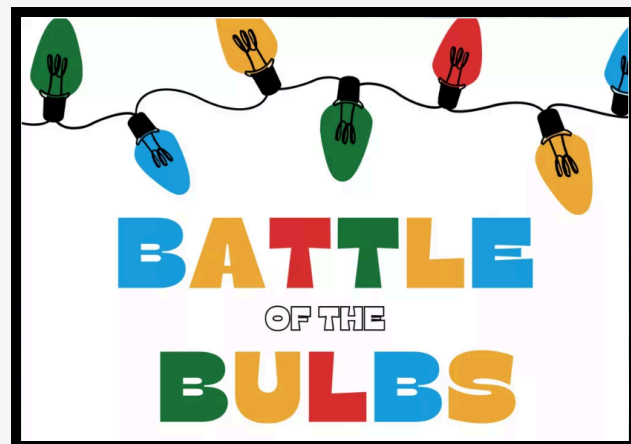

Willows Fire Department Launches Non-Transport Advanced Life Support (ALS) Services

November 18th 2025

Willows, CA — The Willows Fire Department is proud to announce the official launch of its Non-Transport Advanced Life Support (ALS) program, a major advancement in the level of emergency medical care available to the Willows community and surrounding areas.

Beginning immediately, Willows Fire personnel assigned to ALS duties—Advanced EMTs and Paramedics—will deliver rapid, high-level medical assessment and treatment on emergency scenes prior to ambulance arrival. This enhancement ensures that patients experiencing cardiac, respiratory, traumatic, or other life-threatening emergencies receive critical interventions when every second matters.

“Our goal is to provide the highest standard of service to the people of Willows,” said Fire Chief Nathan Monck. “The launch of our ALS program represents a significant step forward in our ability to save lives. Our team has worked tirelessly to bring this capability to our community, and we are proud to officially place it into service.”

The non-transport ALS model allows Willows Fire to deploy ALS-trained personnel on fire apparatus and quick-response units, working in coordination with local ambulance providers for continued care and patient transport. This system ensures a seamless blend of rapid intervention and continuity of care throughout an emergency.

The implementation of the ALS program also helps address a critical gap created by the closure of Glenn Medical Center. With no local hospital available, ambulance transport times have increased significantly due to longer travel distances and higher call volumes throughout the region. The new ALS capability ensures that advanced medical interventions can begin immediately—even when transport units are delayed—providing vital care during those extended response and transport intervals.

The Willows Fire Department extends its gratitude to the partners who helped make this program possible:

- The Willows City Council, for authorizing and supporting the funding needed to establish the ALS service.
- Cal Water, for providing grant funding essential to the purchase of advanced cardiac monitors used by ALS personnel.
- The Glenn County Board of Supervisors, for enabling Dr. Garrison, Glenn County Public Health Officer, to serve as the department’s Medical Director and provide clinical oversight for the program.

“These partnerships were instrumental,” Chief Monck added. “With the increased strain on the local EMS system following the hospital closure, our ALS program fills a critical community need. We are grateful to our community leaders, regional partners, and grant supporters for making this lifesaving service possible.”



Major Incidents

Residential Structure Fire – 400 block of East Wood Street

On November 25, the Willows Fire Department (WFD) responded to a residential structure fire in the 400 block of East Wood Street. Crews arrived to find a detached residential conversion with light smoke showing. Firefighters quickly initiated an offensive fire attack and were able to confine the fire to an exterior porch/lean-to area, with only minimal extension into the structure. No injuries were reported, and six residents were displaced as a result of the incident. The address was forwarded to the Glenn County Building Department due to concerns related to an illegal residential conversion and improper egress.

Multi-Unit Apartment Fire – 1201 West Wood Street

In the early morning hours of November 22 at approximately 12:30 a.m., WFD was dispatched to a reported structure fire at a multi-unit, multi-family residence located at 1201 West Wood Street. Upon arrival, crews observed smoke coming from a second-story apartment. Firefighters initiated an offensive fire attack and located a working fire in a kitchen storage closet. WFD extinguished the fire and successfully contained it to the room of origin, preventing extension into the attic space. No injuries were reported, and two residents were displaced.

Training

Flood Preparation & Pump System Walkthrough

As part of annual flood preparedness efforts, the Willows Fire Department (WFD) conducted a pump system walkthrough and training with Glenn County Public Works. This joint training helps ensure WFD staff are familiar with pump locations, access points, and basic

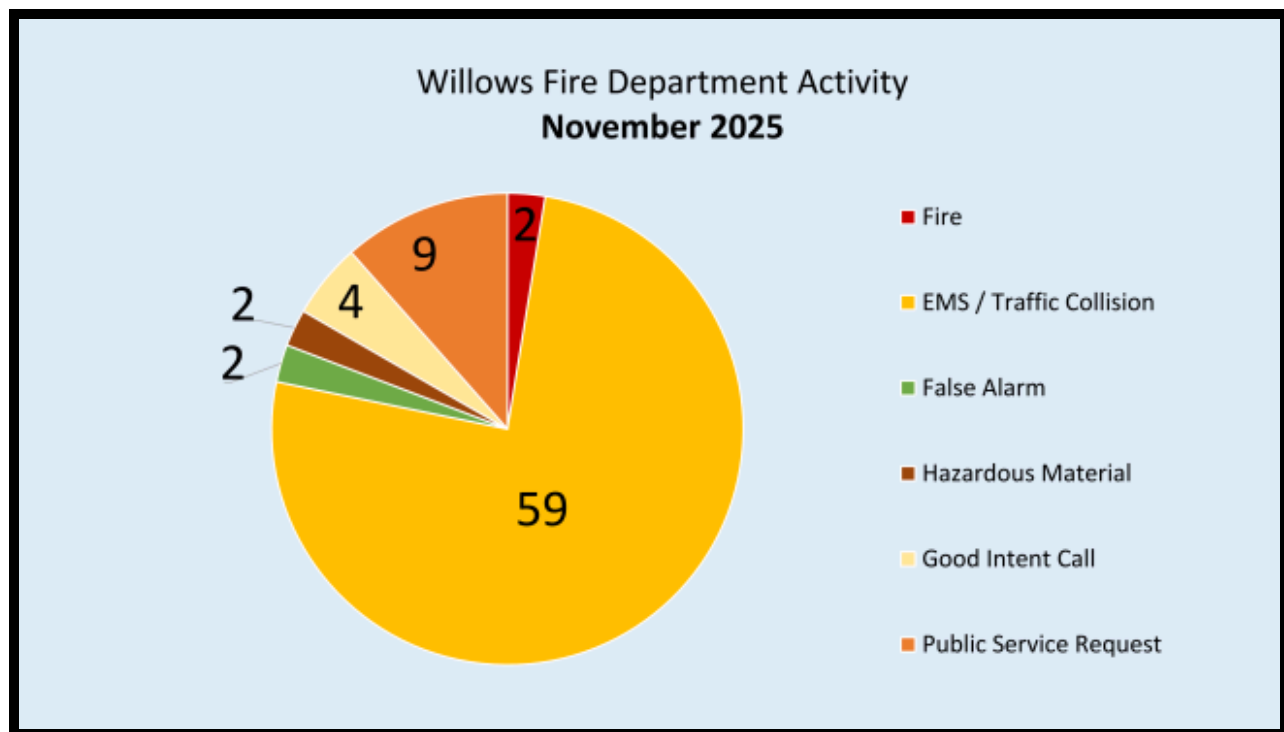
operations so the equipment can be used effectively and safely if needed during emergency responses.

Monthly Drill Night

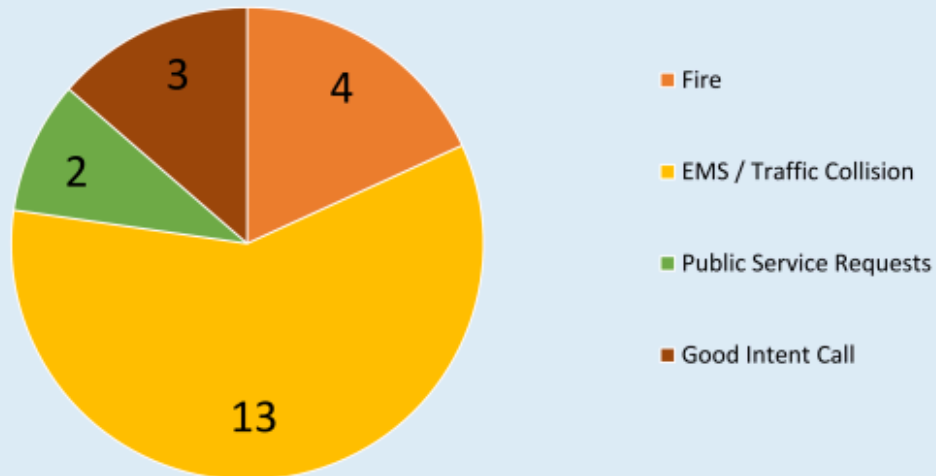
WFD also held its two regular monthly drill nights on the first and second Tuesday of the month. Firefighters focused on core response skills, including hose deployment and movement through structures, search techniques, and victim removal methods. These ongoing drills help keep crews prepared to respond quickly and efficiently to a wide range of incidents.

Chaplain Training

WFD Volunteer Sylvin Finger attended a three-day Fire Department Chaplain Training in Lodi from November 4–6. Sylvin joined the department approximately six months ago and serves the community as a Pastor in his professional life. Volunteer Finger's training will strengthen WFD's ability to provide emotional and spiritual support to community members and responders immediately following difficult incidents.

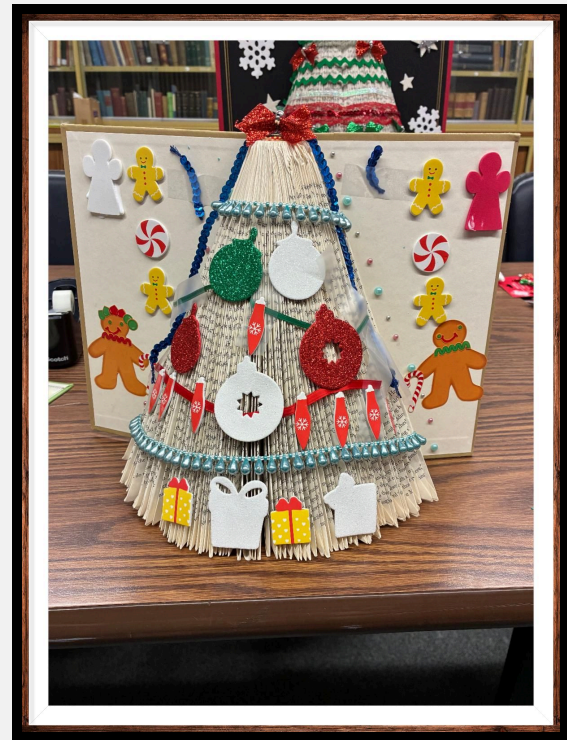
The Willows Library Board met on Thursday, December 11 at 11:00 a.m.

Library Collection Updates

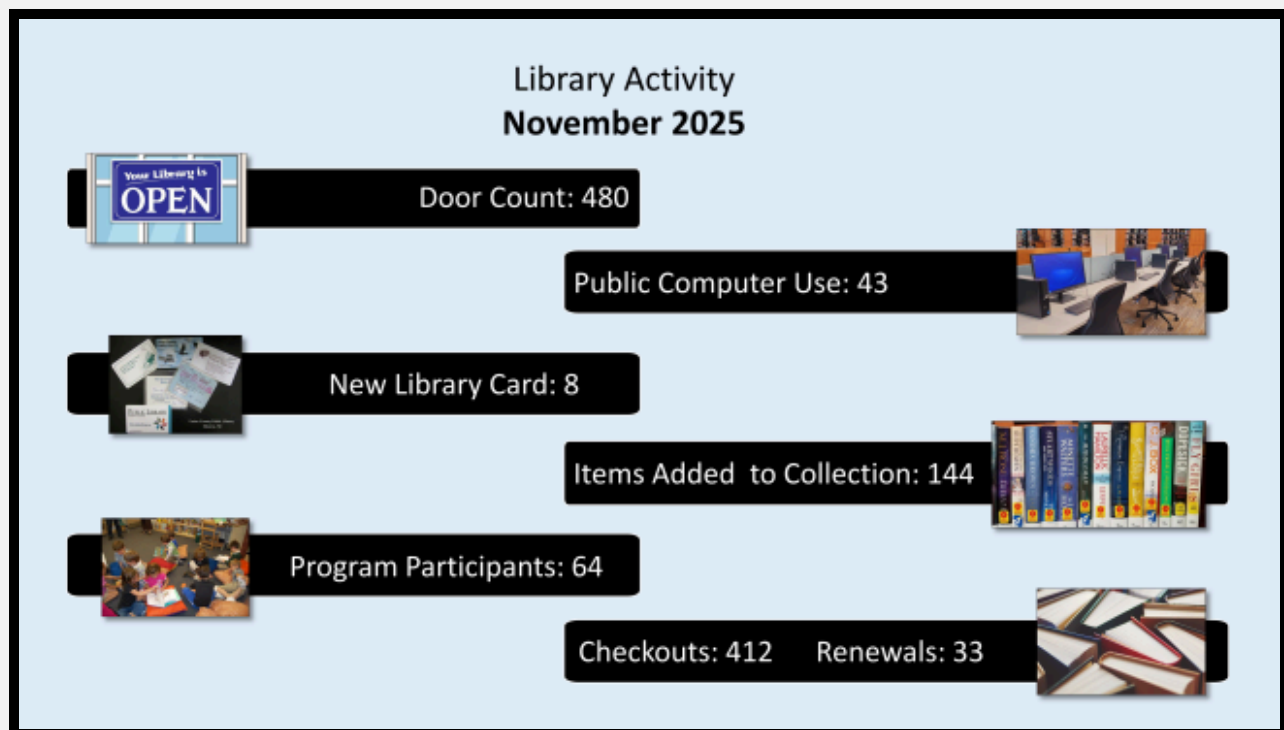
